## Trek Larapinta Booking Conditions.

It is a requirement of True Way Treks Pty Ltd and Trek Larapinta as responsible and accredited tour operators to have a set of booking conditions that form a contract between you our customer and us as the tour operator. Please read carefully and sign and date the bottom of this form. We have tried to keep it short and to the point please talk to us with any concerns you may have.

### To Book your trip.

Simply fill in the booking form and follow the payment details. We require a 20% non refundable deposit to confirm your place on the tour.

### Payment.

Payment to be made as per the booking form guidelines, or as directed by Trek Larapinta staff.

Payment to be made in Australian Dollars.

### Cancellations.

As per booking form cancellation policy.

### Travel Insurance.

Please take out travel insurance for the duration of your travel and tour period.

### Fitness.

With the exception of the Town Bore 3 day cultural tour, all tours require a moderate to high level of fitness and a degree of mental stamina.

Being physically prepared will ensure you gain maximum involvement and enjoyment of the trip.

See physical preparation and requirements in your tour notes or talk to us about being physically prepared or consult your GP before booking on the tour.

### Health.

We need to be aware of any medical conditions that may affect you during your time with us. Please advise us on the Booking Form of any medications you are taking, medical conditions and any previous injuries or operations you may have or had. We need to know so that we can ensure maximum comfort and enjoyment for you during your time with us.

Consult your GP before Larapinta trail tours if you have any pre existing medical condition which may affect you whilst on tour. If taking any medication please make sure you have adequate supplies for the duration of the tour.

### Travelling with True Way Treks Pty Ltd and Trek Larapinta.

Your safety and wellbeing is paramount to our operation, we structure, modify and conduct the tours with these two points in mind.

We walk together or within sight of each other and adjust the pace as required for the comfort and safety of all participants, please consider this as part of your booking.

We treat each tour as unique and endeavour to provide the best possible experience for each group.

We hold all the necessary permits and fulfill all other requirements to legally run all of our tours.

### Cancellation of tour.

Cancellations to tours by the company may happen if minimum numbers are not reached, a minimum of 30 days notice will be given to you with the option to book onto another tour or receive a full refund. Cancellations due to unforeseen circumstances on tour whilst very rare may happen

### Changes made during tour

Changes to the itinerary may and do occur in response to weather, campsite and road conditions. Changes also take place in response to group needs.

Changes are made at the discretion of tour leaders.

### Be Responsible

True Way Treks Pty Ltd and Trek Larapinta feels great responsibility for its groups and the environmental and cultural landscape we operate in. We do our best to nurture the needs of each person for the benefit of the whole experience

But it is your responsibility to be prepared for the physical and mental demands of each tour. We need: your active participation to ensure the safety and wellbeing of the group, for you to be aware of a minimal impact approach to the tour, and for you to consider the cultural requests and values of certain areas.

### Assumption of risk

You acknowledge and accept that:

You are participating in an adventure activity that has high and inherent risks and dangers.

Tours are undertaken in remote areas where expert medical aid and limit of communications may mean delays in assistance in the event of injury or death.

Adverse weather conditions may mean changes to the trip structure, itinerary and may affect your personal comfort.

### Waiver of liability.

The participant acknowledges and agrees that due to the nature of that activity it would be unreasonable for Trek Larapinta or True Way Treks Pty Ltd to be in any way responsible for any injury to or death to the participant unless the company is willfully negligent and the participant hereby, to the full extent permitted by law, waives all of his legal rights of action against and fully releases the company, its office bearers, directors, employees or agents for loss, damages, injury or death howsoever arising out of or in relation to the participation by the participant in the activities conducted or organised by True Way Treks Pty Ltd or Trek Larapinta.

In order to preserve your own and others' safety, if you are found to not be responsible for the booking conditions, act in a way that neglects group safety or willfully damages the environment or cultural sites, you may be asked to leave the tour or refused entry on the tour at your own expense.
